****1. Service Overview****

Cloud Gaming Hosting (CGS Hosting) provides hosting services for virtual servers dedicated to running Minecraft gameplay. These services enable clients to host Minecraft servers for personal or community play, provided that use of the servers follows the guidelines and other limitations in these terms.

****2. Account Registration****

Eligibility: You must be at least thirteen years old to use the Service. In creating an account, you represent that you are at least thirteen years old and fully capable of entering into and complying with these terms.

Account Information: You agree to provide current, complete, and accurate information during the time of registration and to keep this information updated.

You are responsible for the security of your account, and are fully responsible for all activities that occur under your account.

****3. User Conduct****

You agree to use our services in a responsible, ethical, and legal manner. In no limiting sense, the following are some of the unacceptable uses:

Abuse: To harass, bully, or distribute any harmful or hateful material.

Copyright: To host or distribute unauthorized copyrighted material or anything that infringes the intellectual property rights.

Illegal Activities: To use our services in conducting any illegal or prohibited activities. Any violation of these may lead to the suspension or termination of your account without prior notice.

****4. Server Content and Use****

Backups: We are not responsible for backing up data on your server. Users are encouraged to create backups of their data on a regular basis.

Content Responsibility: You are responsible for all content hosted on your server, including compliance with Minecraft's own End User License Agreement (EULA).

Resource Abuse: You shall not use excessive bandwidth or server resources beyond that which would be required for the ordinary operation of a hosting account by a customer of a similar hosting plan as that which you have signed up for.

****5. Billing and Payment****

Billing: With the purchase of a hosting plan, you agree to pay all fees applicable to such plan selected by you. All fees are payable in advance, and we may change our prices from time to time.

Refunds: Any refund policies are as stated on our website. Generally, we do not provide refunds except when using a promotional offer that specifically provides for a refund, or where there is an outright failure of service on our part.

Late Payments: If your account is past due, we reserve the right to suspend or cancel your services without notification.

****6. Service Availability****

We work to ensure that the up-time of and access to our services are as high as possible. Considering we are a service delivered online, we cannot guarantee accessibility without interruption. Sometimes, we will have to take the service offline for maintenance, upgrades, or other reasons, during which time there may be periods of downtime. In these situations, we shall not be liable for damages or losses.
